Mr. Heinold made the motion to approve the February claims as presented. Mr. Houchins seconded the motion. Motion carried 4-0.

Skinner Trucking Corp- FPBH Engineering Firm – Approve Site Plans/Drain Calculations – 012-02604-00

Mr. Rust introduced Mr. Adam Cooper from FPBH Engineering Firm, to speak for their client, Skinner Trucking Corporation. Skinner Trucking is wanting to put in a drop lot for semitrailers. 
Mr. Heinold made a motion to adjourn. Mr. Houchins seconded the motion. Motion carried 4-0.






